

## Guidelines for Nomination Process

### Category: Male Entrepreneur of the Year

Awarded to a Male Entrepreneur of Indian origin who has established a high profile in the Canadian and the global business community; demonstrated achievements in a business product and/or business process innovation and development; strong leadership skills and has contributed to the community.

### Eligibility:

- Any Male entrepreneur of Indian origin with an operating business based in Canada<sup>1</sup>.
- Minimum annual turnover of \$ 10 million and/or consistent growth over the past three years in excess of annual turnover of 10 million.
- In any given year, a nominee may be nominated in one category only.
- Previous recipients are not eligible to be re-nominated.
- Nomination from 2016 & 2017 will be considered along with 2018 nominations, only if it is agreed to by the nominee and current and updated information is submitted.

### Criteria for selection:

- Established profile in the Canadian and global business community
- Demonstrable achievements in business product and/or business process innovation and development
- Demonstrated leadership skills
- Contribution to the community

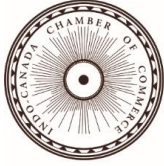

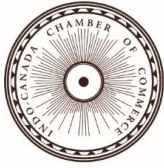

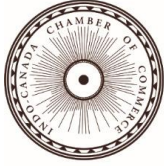

## Submission Guidelines:

- The attached Nomination Form must be complete in all parts; with signatures of both the Nominator and the Nominee (forms without signatures are ineligible).
- Written submissions, including initial narrative and exhibits, should not exceed 2/3 pages.
- A detailed bio along with a summary of the background and history of the business, professional, and/or other activities must be included in the written submission.
- Provide specific and factual information, where possible with concrete examples of what was done, how it was done, what benefits or results were realized.
- Supporting materials must be current and attached to or included with the form.
- While written submissions are allowed, electronic submissions are preferred (CD or USB stick; please do not send via e-mail).
- Completed Forms should reach ICCC office on or before the submission date: **April 30, 2018-** (924 The East Mall, Etobicoke ON M9B 6K1)

## Evaluation process:

- The Advisory Board of the ICCC, an independent body of the Chamber, evaluates and selects the award recipient from the nominees.
- ICCC intends to engage an independent third-party to assist the chamber & its advisory board. You hereby authorize us to disclose the information to the independent third-party engaged by us.
- The Advisory Board may seek additional information from the nominator and / or the nominee during the evaluation process.
